Chelsey Johnson is an architectural historian with extensive experience in cultural resource management. Her regular duties include conducting cultural resource surveys; drafting National Register of Historic Places eligibility evaluations, Section 106 effects assessments, and Section 4(f) evaluations; researching and developing historic contexts and context study reports; drafting NRHP nominations; and facilitating Section 106 mitigation projects, including the development and design of interpretive materials and public-facing literature. She has served as lead architectural historian on projects for a wide variety of federal and state agencies as well as municipalities, nonprofit organizations, and individuals. She has worked on projects in Tennessee, Kentucky, Alabama, Mississippi, West Virginia, Virginia, Louisiana, and Indiana.

Chelsey's responsibilities include planning and leading field surveys, determining appropriate levels of documentation and evaluation for properties, designing and implementing research strategies using digital and physical resources and repositories, developing historic contexts, and preparing technical reports that provide summary findings and recommendations. She is highly skilled in research, writing, and qualitative and quantitative analysis methods, bringing a diverse professional and educational background to complement her training in historic preservation, oral history, and documentary fieldwork.

Chelsey holds Master of Arts degrees in History and Appalachian Studies from Appalachian State University. Her graduate research focused on the material culture and vernacular architecture of Southern and Central Appalachia, as well as historic and contemporary folk traditions and foodways of the region.
