As an architectural historian at CRA, Evan's responsibilities include researching and documenting historic properties by conducting archival research and field surveys, evaluating the significance of historic properties, and preparing written reports that provide summary findings and recommendations. His project work also includes context development, development of interpretive products, Section 106 consultation, and preservation planning.

Evan Christodoulou is currently in the process of finishing his Master's Project to obtain a Master of Historic Preservation degree from the University of Kentucky. While at UK, his coursework included historic preservation principles and planning, cultural landscapes, historical structural systems and building materials, building and landscape documentation, American architectural history, and urban planning. His research revolves around investigating the underrepresentation of minority groups within preservation practices. Mr. Christodoulou's primary case study revolves around Native American representation within McConnell Springs Park – a site within Lexington, Kentucky, that is tied to the city's settlement history.
